

Pandemic Addendum

1. Facial Coverings for medical purposes and disease prevention. (Masks and Face Shields)
 - a. Inappropriate masks or accessories that advertise, display, or promote any drug (including tobacco or alcohol), sexual innuendo, violence, weaponry, profanity, gang affiliation, hatred bigotry towards any group) are not acceptable.
 - b. All face shields must be accompanied by an approved cloth or medically approved mask.

Students must keep Face Masks on During the entire school Day. Face masks must be worn all day while on school campuses, at school-sponsored events and on school transportation. The only time the face mask may be off is while eating and drinking during allowed times.

Schools may provide supervised mask breaks for small groups of students outdoors, while maintaining more than 6 feet social distancing between individuals. While waiting for parent pick up, the student will be supervised and quarantined from other students, six-foot lines are provided on sidewalks.

If a student removes the face mask and refuses to wear the mask during other times, then the student will have to be picked up from school and taken home.

The New Mexico Public Education Department allows Local school districts and charter school policies set forth the number of times a student may remove a face mask and the number of warnings a student may receive prior to being sent home to work remotely. If a student is reminded two (2) times to wear his/her face covering correctly, the student will be placed in a quarantine setting until a parent/guardian can take the student home to work remotely for the remainder of the day. The second time a student is removed from school for insubordination, that student will be placed on remote learning only for the remainder of the semester.

2. Pandemic re-entry protocols.
 - a. Refusal to clean desks.
 - b. Refusal to sit where instructed by the teacher.
 - c. Refusal to follow the social distancing/directional arrows and/or maintaining social distancing and physical contact.
 - d. Follow procedures as outlined by all school personnel.
 - e. Stay with the same recess pods as directed by administration and lunch monitors.
 - f. Wear you badge around the neck visibly every day.
 - g. Sharing food, eating food other than breakfast or lunch times.
 - h. Must follow all safety protocols in place.

If a student is reminded two (2) times to conduct his/her self correctly, in accordance with RMSD/RMS pandemic policies the student will be placed in a quarantine setting until a parent/guardian can take the student home to work remotely for the remainder of the day. The second time a student is removed from school for this insubordination, that student will be placed on remote learning only, for the remainder of the semester.

3. Modified Dress Code Basics for Hybrid Re-opening, Spring 2021 only. Uniform dress will resume in the fall of 2021.
 - a. Jeans or uniform pants (no rips, tears, sagging, athletic shorts, sweats, or pajamas)
 - b. Shirts (tucked in) (no sleeveless shirts) (no inappropriate logos or messages)
 - c. Shoes: Lace up or slip on closed toed shoes or boots
 - d. Sweatshirts or hoodies may be worn in the building, but hoods must remain off the head.
4. Remote behavior
 - a. Cameras are to remain on unless otherwise specified by the teacher.
 - b. Students are to remain "framed" up on the screen for engagement.
 - c. Students must follow all protocols outlined by the teacher for remote learning.
 - d. Do not access platforms, links or websites deemed i

Remote Learning Policies

Attendance Policy

Students are expected to join our Zoom meetings or Google Meets meetings every day when class begins. We will follow the bell schedule for each period. If students do not attend a meeting, they will be marked absent. If students are more than 15 minutes late to the meeting, they will be marked absent. Students must communicate with the teacher if they are having internet issues, tried joining, but could not. They must also check the Hapara workspace for assignments they need to complete and submit for that day.

Zoom/Google Meets Etiquette

Students must follow the Zoom or Google Meets etiquette guidelines. Their learning space should be distraction free. They need to be sitting up in order to focus. Students should be in a chair, not on a bed or laying on a couch. No eating during class time. Students should not have conversations with others around them. They should be paying attention to the teacher and the lesson. Video must be on unless the teacher tells the class otherwise.

Expectations and Consequences

Students are expected to use their Chromebooks for school purposes. They should not be on YouTube, Netflix, or playing games during class time. They need to use their time to complete assignments and submit them. Students will receive an email or have a conversation with the teacher if it is the first offense. If the student continues to break policies, a phone call will be made home. As the third offense, the student will be written a behavioral referral will be issued.
