## **RMSD Update**

It wasn't "if" we would experience a positive Covid-19 test within Warrior Nation, but "when". The "when" happened to be this week, with confirmation arriving Wednesday afternoon. We systematically reviewed and followed all of the required protocols from the New Mexico Department of Health, Environmental Department, and Public Education Department. We continue to work with state officials to assure that all procedures and protocols are followed.

What can be shared is that a District employee, housed at Ruidoso Middle School, but who performs multiple roles in the District tested positive for Covid-19. All individuals who were identified as "close contacts" within the 48 hour contact-window, have received direct notification, are in quarantine protocol and been provided further information. I wish continued health and safety for everyone connected with this exposure.

As with the previous secondary contact situations that our District has experienced, everyone involved worked positively and professionally in assuing that contact tracing and communication protocols were followed. This situation will be the basis for this week's "what we know" and "what we don't know" columns.

## What We Know

**Prevention:** The four most effective behaviors to prevent the spread of Covid-19 are: 1) Wear a mask at all times; 2) Maintain physical distance (6 feet); 3) Wash your hands often; and 4) Clean and sanitize high-touch surfaces.

**A "Close Contact":** is defined as: 1) a person who came within six (6) feet of the positive individual (even while wearing a mask) for longer than three (3) minutes; 2) all students and staff who were in the same classroom with the individual; and 3) all students who were on the same bus as the individual.

**Contact Tracing:** is defined as the process of reaching out to "close contacts" in order to ensure that they take the necessary precautions and receive any needed testing. Contact tracing is also the most effective way to prevent a positive case from becoming mass cases.

**Retracing Your Steps:** In responding to this first positive case, we found that it is and will be extremely helpful to remember where you have been and who you have been in contact with. This helps with mandatory reporting requirements and the sharing of information.



## What We Don't Know

**Outcomes:** Even though we have followed protocol and procedure, we cannot know with certainty how effective our responses will be towards containment.
